The property offered for sale consists of residential, commercial real estate, vacant land, business establishments, financial instruments and a wide range of personal property items such as motor vehicles, boats, aircraft, jewelry, art, antiques and collectibles.

This is a list of contract service providers and federal agencies who have been authorized to sell forfeited property for the USMS on a recurring basis. The list provides information on company/agency names, locations, and telephone numbers. Please contact the companies/agencies listed for information on property that is currently available for sale.

Please note that the list is subject to change. Forfeited property may not be available for sale at all times. Written inquiries to service providers must be accompanied by a self-addressed/stamped envelope. Forfeited real property is normally listed for sale by authorized brokers in local Multiple Listing Services. Special interest items are sometimes advertised in trade publications and special interest periodicals.

The USMS reserves the right to reject any individual offer to purchase forfeited property. Individual offers may be rejected because of their relationship to a defendant in a related criminal matter or for other law enforcement reasons as determined by the USMS. Individual offers may also be rejected to avoid a conflict of interest, or the appearance of a conflict of interest because of the offers' relationship to an employee of any Federal, state or local governmental agency, or to any contractor, subcontractor or their employees performing services related to the maintenance, custody or sale of forfeited property.

This list of contract service providers is considered to be public information and is not intended for commercial publication, reproduction, or sale in any manner. The National Sellers List is reviewed and revised periodically.
