

## KCA Labs GoFundMe Vape Testing Report

21 May 2021

### Project

GoFundMe was used to raise funds for the purchase and testing of ten vape cartridges marketed as containing mostly Delta-8 THC. The following was posted as a description of the project:

“An ongoing debate about the prevalence of contaminants in vape cartridges and distillates has led to the need for a product survey and testing.

KCA Labs will purchase 10 d8 vape cartridges sourced randomly at retail in Kentucky.

The 10 cartridges will then be tested by KCA Labs for the presence of olivetol, p-cresol, and residual solvents.

\$1000 is needed to purchase materials and pay for the testing. Additional funding that is accumulated will pay for additional samples or a separate study.”

### Results

The cartridges were sourced locally to the Central Kentucky area at the end of April 2021. It is worth noting the cartridges were purchased shortly after the Kentucky Department of Agriculture’s letter regarding Delta-8 THC.

All the cartridges obtained were chosen based on availability with one cartridge purchased per retail location.
